Scope and Content Note

The materials in FOIA 22-18621-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-18621-F requested emails of Denis McDonough referring to the Senate Select Committee on Intelligence (SSCI) report on the Central Intelligence Agency (CIA) rendition, detention, and interrogation (RDI) or torture programs or referring to the CIA spying on Senate or Senate staffers or hacking into their computers. (This report became known by the shorthand name the "Torture Report.")

This FOIA contains emails to Denis McDonough scheduling requests for meetings, articles circulated via email, and official statements.

System of Arrangement

The materials in FOIA 22-18621-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home

and shared drives used by White House staff.
