These materials are from the Interagency Security Classification Appeals Board (ISCAP) files and consist of materials related to classification appeals and mandatory declassification reviews received by ISCAP on prepublication reviews, military handbooks, and military information disclosures.

It should be noted that many of the documents in this FOIA have been closed due to National Security classification and/or exemptions of the Freedom of Information Act.
