## **Scope and Content Note**

The materials in FOIA 22-16611-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials. FOIA 22-16611-F requested all photographs taken by Pete Souza during an interview of President Obama by Tammy Lytle of AARP Bulletin in the Oval Office on August 16, 2012. This FOIA primarily contains photographs of President Obama participating in the interview with Tammy Lytle and photographer Brendan Hoffman. Upon their return from summer camp, daughters Malia and Sasha, along with First Lady Michelle Obama and Bo, dropped by the Oval Office while the interview was taking place.

## **System of Arrangement**

The materials in FOIA 22-16611-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials. Records responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
