Scope and Content Note

The materials in FOIA 22-26843-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 22-26843-F requested materials related to all requests for information, analyses, summaries, assessments, transcripts, or similar records submitted to any Intelligence Community member agency or any officer, employee, or representative thereof by former National Security Advisor Susan Rice regarding the identities of U.S. citizens associated with the Trump presidential campaign or transition team who were identified pursuant to intelligence collection activities, from January 1, 2016 to January 20, 2017.

This FOIA primarily contains emails. The emails include transcripts of press briefings, news summaries, and responses sent to or from Susan Rice. It should be noted that many of the documents in this FOIA have been closed due to National Security classification and/or exemptions of the Freedom of Information Act. An additional portion of classified records related to this request has not yet been processed. Records will be provided as they become available.

System of Arrangement

The materials in FOIA 22-26843-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Barack Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President Barack Obama. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
