FOIA 22-25183-F requested video and photos of President Obama talking with members of the 2012 Summer White House intern class on August 7, 2012.

This FOIA primarily contains photographs and footage of President Obama greeting the Intern Leaders and talking with the entire intern class from the 2012 Summer Internship Program on August 7, 2012.

System of Arrangement

The materials in FOIA 22-25183-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records and White House Communications Agency.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
