Scope and Content Note

FOIA 22-16558-F.2 requested any and all photographs of Kerry Washington.

This FOIA primarily contains photographs of President Obama and First Lady Michelle Obama hosting a women's history reception in honor of International Women's Day in the East Room on March 8, 2010; First Lady Michelle Obama greeting actress Kerry Washington at the 2015 Global Citizen Festival in Central Park, New York, on September 26, 2015; President Obama and First Lady Michelle Obama greeting Kerry Washington and husband Nnamdi Asomugha during the Kennedy Center Honors reception receiving line in the Blue Room on December 6, 2015; and President Obama and First Lady Michelle Obama greeting Kerry Washington during The United State of Women Summit at the Walter E. Washington Convention Center in Washington, D.C., on June 14, 2016.

System of Arrangement

The materials in FOIA 22-16558-F.2 are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
