FOIA 23-05306-F requested documents from the White House Office of Counsel to President Obama related to Jennifer Choe Groves.

This FOIA primarily contains nomination files related to Jennifer Choe Groves and nine other July 2015 Presidential Appointees, which includes email printouts, nomination and resignation letters, resumes, appointee record summaries, and news articles.
