## **Scope and Content Note**

The materials in FOIA 22-64251-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-64251-F requested all photographs of the Easter Prayer Breakfast event on April 7, 2015.

This FOIA primarily contains photographs of President Obama and Vice President Biden greeting and taking photos with performers prior to the event; Vice President Biden introducing President Obama, President Obama delivering remarks, Reverend Amy K. Butler delivering the opening prayer, Amy Grant and the Howard Gospel Choir of Howard University performing, and Sister Donna Markham reading from scripture, all during the Easter Prayer Breakfast; and President Obama and Vice President Biden greeting attendees following the Easter Prayer Breakfast.

## **System of Arrangement**

The materials in FOIA 22-64251-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
