This FOIA primarily contains footage shot by the White House videographer during the Lincoln Concert from January 18, 2009.

## **System of Arrangement**

The materials in FOIA 22-21458-F.2 are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - White House Communications Agency.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject

area.
