FOIA 23-09084-F requested materials related to emails, paperwork, and notes of Peggy Maloney that were boxed and sent to National Archives and Records Administration (NARA) on January 3, 2017.

This FOIA primarily contains email printouts, news articles, cover sheets, and forms of Peggy Maloney from 2008 to 2016.

System of Arrangement

The materials in FOIA 23-09084-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Staff Member Office Files

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity. Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method

maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
