FOIA 22-55801-F requested photographs from President Obama's visit to the Union for Reform Judaism Biennial on December 16, 2011.

This FOIA primarily contains photographs of President Obama meeting with Israeli Deputy Prime Minister and Defense Minister Ehud Barak backstage prior to remarks, taking photos with leadership and reform movement supporters, and delivering remarks at the 71st General Assembly of the Union for Reform Judaism at the Gaylord National Hotel and Convention Center in National Harbor, Maryland, on December 16, 2011.

## **System of Arrangement**

The materials in FOIA 22-55801-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home

and shared drives used by White House staff.
