FOIA 22-32386-F requested materials related to any emails or letters sent from Jake Sullivan (Clinton Campaign), Jennifer Palmieri, (Clinton Campaign), Robby Mook (Clinton Campaign) or Hillary Clinton to President Obama, his Chief of Staff or Susan Rice for the period of January 1, 2016 through January 20, 2017.

This FOIA primarily contains email correspondence from January 2016 between Jake Sullivan and Susan Rice.

System of Arrangement

The materials in FOIA 22-32386-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the

Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
