FOIA 22-61292-F requested any footage of King Salman of Saudi Arabia with his delegation and President Obama on September 4, 2015.

This FOIA primarily contains footage of King Salman bin Abdulaziz of Saudi Arabia arriving at the White House on September 4, 2015, and a Bilateral Meeting that day between President Obama and King Salman on September 4, 2015.

System of Arrangement

The materials in FOIA 22-61292-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas –White House Communications Agency.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
