Scope and Content Note

The materials in FOIA 22-51429-F.2 are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-51429-F.2 requested raw and unreleased footage from the *West Wing Week* episode from July 17, 2015, specifically from time codes :06 - :09, 2:09 – 2:40, and 3:27 – 3:59.

This FOIA primarily contains footage shot by the White House videographer and the military of President Obama holding a press conference on the Nuclear Deal with Iran on July 15, 2015.

System of Arrangement

The materials in FOIA 22-51429-F.2 are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Communications Agency.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
