FOIA 23-45597-F requested photographs from President Obama's meetings at the White House with the chief executives of banks in March and December of 2009.

This FOIA primarily contains photographs of President Obama holding a meeting with bankers in the State Dining Room on March 27, 2009; and bank executives in the Roosevelt Room and making a statement afterward in the Diplomatic Reception Room on December 14, 2009.

### **System of Arrangement**

The materials in FOIA 23-45597-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the

Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
