FOIA 24-06295-F requested photos, videos, and any other digital media capturing the White House Hanukkah Party on December 8, 2011. All photos from this Hanukkah Reception have been previously released through [FOIA request 22-41741-F](#) and [systematic review](#).

This FOIA primarily contains footage from the Hanukkah Reception. There is also footage of the preparations for the reception, including the menorah used at the event and the kosher White House Kitchen.

System of Arrangement

The materials in FOIA 24-06295-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related

Documents responsive to this FOIA were found in these collection areas -White House Communications Agency.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
