FOIA 22-16572-F.4 requested all photos and videos from White House and Camp David movie screenings. (All photos responsive to this request were previously released in [Segment 1](#).)

This FOIA primarily contains footage by the White House videographer at the screenings of the film "Lincoln" on November 15, 2012, the documentary "National Parks: America's Best Idea" on September 17, 2009, and the film "Thurgood" on February 16, 2011; all at the White House.

System of Arrangement

The materials in FOIA 22-16572-F.4 are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Communications Agency.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
