FOIA 22-21129-F requested materials related to communications between Susan Rice and President Obama between January 1, 2015 and June 15, 2015 containing any of the following terms: Afghanistan, Taliban, or ghani.

This FOIA primarily contains letters to Congress and resolutions to authorize for the limited use of the United States Armed Forces against the Islamic State of Iraq and the Levant.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available, and updates will be made to this Finding Aid.

# **System of Arrangement**

The materials in FOIA 22-21129-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Obama Presidential Electronic Records.

WHORM Subject and WHORM Alpha Files are processed at the document level. The WHORM Alpha File was compiled by the White House Office of Records Management and is a series of documents arranged by name of persons, organizations, or events.

The WHORM Subject File was compiled by the White House Office of Records Management and consists of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories, including a detailed description of each category, is available on the National Archives Catalog.

The Executive Office of the President (EOP) instance of the Electronic Records
Archive (ERA) contains electronic records created or received by Obama
administration staff. These records are stored in Search and Access Sets (SAS) that
represent their originating computer program, such as Exchange Email or the
Worker and Visitor Entry System (WAVES). In addition to records captured from the
White House's electronic systems, EOP-ERA also contains records from the home
and shared drives used by
White House staff
