Scope and Content Note

The materials in FOIA 24-38489-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 24-38489-F requested White House Communications Agency (WHCA) video footage filmed during President Obama's visit to Moscow, Russia.

This FOIA primarily contains footage of President Obama at the Parallel Civil Society Summit at the Metropol Hotel, and the New Economic School graduation ceremony at Gostiny Dvor. First Lady Michelle Obama accompanied at the graduation ceremony. There is also footage of pool sprays of President Obama meeting with Prime Minister Vladimir Putin at Putin's dacha, and President Dmitry Medvedev at the Kremlin.

System of Arrangement

The materials in FOIA 24-38489-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Communications Agency.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
