## **Scope and Content Note**

The materials in FOIA 24-40149-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 24-40149-F requested all photos from the White House Tribal Nations Conference and meetings with Tribal Leaders from December 2, 2011; December 5, 2012; and November 13, 2013.

This FOIA primarily contains photographs of President Obama delivering remarks at the Tribal Nations Conference at the Department of the Interior in Washington, D.C., on those three dates. There are also photos of President Obama meeting with Tribal Leaders in the Eisenhower Executive Office Building on December 2, 2011.

## **System of Arrangement**

The materials in FOIA 24-40149-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
