FOIA 24-39085-F requested video footage of the musical performances at the White House State Dinner for President Felipe Calderón.

This FOIA primarily contains footage from the State Dinner 5/19/2010, including toasts by Presidents Obama and Calderón and one song performed by Rodrigo y Gabriela.

## **System of Arrangement**

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
