FOIA 22-21416-F requested materials related to files on Rebecca Hardcastle Wright, particularly correspondence with John Podesta or the White House.

This FOIA primarily contains gift receipt files and email correspondence. Email correspondence includes meeting requests, gift receipts, and an Exoconscious Blog mass message.

System of Arrangement

The materials in FOIA 22-21416-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

Electronic Records

Email - Presidential contains 11 assets, of which 10 are withheld in part and 1 is withheld in full.

Shared drive - OA contains 10 assets, of which 10 are released in full.

Shared drive - WHO contains 12 assets, of which 4 are released in full and 8 are withheld in full.
