## **Scope and Content Note**

The materials in FOIA 24-42532-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 24-42532-F requested behind the scenes footage before President Obama began a taping session or interview, such as any available footage of the President entering the room and preparing pre-filming. The request was narrowed to include all Weekly Address tapings from 2009 after correspondence with the requester.

This FOIA primarily contains footage of President Obama recording Weekly Addresses from January through April, 2009.

## **System of Arrangement**

The materials in FOIA 24-42532-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - White House Communications Agency.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
