FOIA 22-33811-F requested materials related to all emails, communications, or correspondence to/from “americanprogress.org,” “americanprogressaction.org,” “wyssfoundation.org,” “wyssactionfund.org,” “bergeractionfund.org,” or “loreda.org” between February 1, 2015 to February 1, 2017 in the White House staff email account of Christy Goldfuss.

This FOIA primarily contains email correspondence between Christy Goldfuss and the Center for American Progress, Wyss Foundation, Burger Action Fund, or Loreda, dated from February 1, 2015 to January 20, 2017. The emails contain news clippings, meeting requests, and Center for American Progress reports.

#### System of Arrangement

The materials in FOIA 22-33811-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House’s electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
