FOIA 22-21210-F requested materials related to emails between President Barack Obama or other Executive Office of the President staff and the Department of Justice from October 26, 2016 to January 20, 2017.

This FOIA primarily contains email correspondence, including event invitations, a court testimony scheduling notification, and end of service notices for Association of the United States Army (AUSA) attorneys.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available, and updates will be made to this Finding Aid.

System of Arrangement

The materials in FOIA 22-21210-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the

White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff..
