## **Scope and Content Note**

The materials in FOIA 24-40140-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 24-40140-F requested all videos and photographs containing Harvard professor Henry Louis Gates, Jr.

This FOIA primarily contains photographs of President Barack Obama greeting Henry Louis Gates, Jr. and Lawrence Bobo in the Blue Room during a U.S.-Africa Leaders Summit dinner on August 5, 2014.

There is also video footage from the meeting between President Obama, Vice President Biden, Henry Louis Gates Jr., and James Crowley in the Rose Garden on July 30, 2009.

## **System of Arrangement**

The materials in FOIA 24-40140-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records and White House Communications Agency.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
