Scope and Content Note

The materials in FOIA 22-21420-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-21420-F requested all files, correspondence, meetings, and calls between President Obama or any White House Staff and actor Will Smith and or his son Jaden Smith. All Will Smith photos were released in another FOIA.

This FOIA primarily contains photographs of Michelle Obama, Jada Pinkett Smith, Jaden Smith, and Malia and Sasha Obama watching a performance by Willow Smith during the Easter Egg Roll on the South Lawn on April 25, 2011. Audiovisual records proposed for opening include an audio clip of President Obama participating in an interview with Will Smith and Jada Pinkett Smith in Oslo, Norway, on December 10, 2009.

System of Arrangement

The materials in FOIA 22-21420-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records and White House Communications Agency.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
