FOIA 24-58605-F requested photographs taken on Monday, May 23, 2011, from Moneygall, Ireland, during the visit of the President and First Lady.

This FOIA primarily contains photographs of President Barack Obama and First Lady Michelle Obama to Moneygall on that day. There are photos of them visiting President Obama's ancestral home, stopping at a gift shop, and greeting people as they walked down Main Street.

System of Arrangement

The materials in FOIA 24-58605-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home

and shared drives used by White House staff.
