FOIA 24-65276-F requested video footage filmed during President Obama's visit to Seattle on October 21, 2010.

This FOIA primarily contains footage of President Obama speaking and answering question on women and the economy in the backyard of the Foss family's house, a visit to the Top Pot Doughnuts, and arrival to and departure from Seattle.

## **System of Arrangement**

The materials in FOIA 24-65276-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - White House Communications Agency.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
