FOIA 24-11039-F.4 requested exchanges between Special Assistant Robert Malley with any of the following organizations from January 1, 2014, to January 20, 2017: Council on Foreign Relations, RAND Corporation, Brookings Institute, Center for Strategic and International Studies (CSIS), American Civil Liberties Union (ACLU), Human Rights Foundation, U.S. Campaign for Palestinian Rights, Arab Community Center for Economic and Social Services (ACCESS), or United Palestinian Appeal (UPA).

This FOIA primarily contains email correspondence of Robert Malley from 2015-2016 related to scheduling requests and outlet media news.

## **System of Arrangement**

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
