## **Scope and Content Note**

The materials in FOIA 22-18632-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-18632-F requested materials related to records on any and all communications documents to include but not limited to, call logs, communications, visitor logs, text messages, notes, meeting minutes, transcriptions, etc. with Jeffrey Epstein and Ghislaine Maxwell.

This FOIA primarily contains correspondence and visitor logs.

Upon re-review of these records in response to an administrative appeal, all 156 electronic records have been determined to be unrelated to Jeffrey Epstein (deceased former financier and convicted criminal; DOB: 1/20/1953). These materials relate to another individual with the same name of Jeffrey Epstein with a different birthdate and Social Security Number.

## **System of Arrangement**

The materials in FOIA 22-18632-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home

and shared drives used by White House staff.

## **Container List**

The following is a list of documents, folders, and electronic search results lists (SRLs) that were processed in response to FOIA 22-18632-F:

### **Electronic Records**

Exchange Email - Presidential (From) contains 3 assets, of which 1 is released in full and 2 are withheld in full.

Exchange Email - Presidential (To) contains 3 assets, of which 3 are withheld in full.

Shared Drive - CEA contains 15 assets, of which 15 are withheld in full.

Shared Drive - NSC contains 1 asset, of which 1 is withheld in full.

Shared Drive - OA assets, of which 1 is withheld in part and 52 are withheld in full.

WAVES contains 4 assets, of which 4 are withheld in part.

Shared Drive - WHO contains 77 assets, of which 77 are withheld in full.
