## **Scope and Content Note**

The materials in FOIA 22-16572-F.6 are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-16572-F.6 requested all photos and videos from White House and Camp David movie screenings. All photos for this FOIA were previously released in segment 1 of this FOIA.

This FOIA primarily contains video clips shot at the screening of the film *Beasts of the Southern Wild* on February 13, 2013; and video clips from the screening of *Mandela: A Long Walk to Freedom* on November 7, 2013. Both events were at the White House.

## **System of Arrangement**

The materials in FOIA 22-16572-F.6 are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - White House Communications Agency.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
