FOIA 22-17819-F requested materials related to correspondence with President Obama regarding Benghazi.

This FOIA primarily contains email and mail correspondence.

## **System of Arrangement**

The materials in FOIA 22-17819-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records and White House Office of Records Management (WHORM) Subject Files

WHORM Subject and WHORM Alpha Files are processed at the document level.

The WHORM Alpha File was compiled by the White House Office of Records Management and is a series of documents arranged by name of persons, organizations, or events.

The WHORM Subject File was compiled by the White House Office of Records Management and consists of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories, including a detailed description of each category, is available [on the National Archives Catalog](#).

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
