FOIA 22-17840-F requested materials related to email correspondence and documents regarding the High-Value Interrogation Group (HIG).

This FOIA primarily contains correspondence, memoranda, reports, scheduling requests, meeting agendas, budgets, and press releases. Topics covered by this material include compiled summaries of news items, materials compiled in preparation for press briefings, congressional communications, and senate briefings, etc.

# **System of Arrangement**

The materials in FOIA 22-17840-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

#### **Electronic Records**

Email - Presidential - From Mueller et al contains 11 assets, of which 3 are withheld in part, and 8 are withheld in full.

Email - Presidential - To Mueller et al contains 72, of which 2 are released in full, 9 are withheld in part, and 61 are withheld in full.

Email - SIP44 contains 10 assets, of which 10 are withheld in full.

Shared Drive - OA contains 16 assets, of which 15 are released in full, 1 is withheld in full.

Shared Drives - CEA contains 13 assets, of which 13 are released in full.

Shared Drives - NSC contains 60 assets, of which 30 are released in full, 30 are withheld in full.

Shared Drives - PIAB contains 11 assets, of which 11 are released in full.

Shared Drives - WHO contains 853 assets, of which 822 are released in full, 6 are withheld in part, and 25 of which are withheld in full.
