The materials in FOIA 22-21119-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-21119-F requested materials related to all emails to and from any and all members of the Obama Administration including Barack Obama which were sent or received from or mentioned "Alex Soros" in the subject line or contents of the email.

This FOIA primarily contains news reports, email correspondence, conference call and event invitations. The bulk of the electronic records proposed for release are related to Alex Soros' Bend the Arc Foundation and various news reports.

System of Arrangement

The materials in FOIA 22-21119-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

Email Other Updated contains 9 assets, of which 1 are released in full, 0 are withheld in part, and 8 are withheld in full.

Email Presidential contains 1244 assets, of which 462 are released in full, 34 are withheld in part, and 748 are withheld in full.
