## Scope and Content Note

The materials in FOIA 22-21458-F.6 are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-21458-F.6 requested all the raw video footage shot by White House Videographers Arun Chaudhary, Hope Hall, and any other official videographer working in the White House during the Obama Administration.

This FOIA primarily contains footage of President Obama filming his segment for the Disney Hall of Presidents on March 4, 2009; meeting with President Lula da Silva from Brazil in the Oval Office on March 14, 2009; and a visit to the Veterans Administration on March 16, 2009.

## System of Arrangement

The materials in FOIA 22-21458-F.6 are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - White House Communications Agency.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
