The materials in FOIA 22-17669-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-17669-F requested materials related to Larry Sinclair.

This FOIA primarily contains email correspondence, compiled news articles, scanned copies of facsimile correspondence, spreadsheets of data compiled from FEC filings, comments and messages from social media platforms, court filings, and registers of gifts received. Included in these documents are court filings mentioning Larry Sinclair's affidavit, correspondence from Larry Sinclair, registers of gifts referencing Larry Sinclair's book, and email correspondence and social media posts mentioning Larry Sinclair.

System of Arrangement

The materials in FOIA 22-17669-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas -

White House Office of Records Management (WHORM) Subject Files and Obama Presidential Electronic Records.

WHORM Subject Files are processed at the document level.

The WHORM Subject File was compiled by the White House Office of Records Management and consists of a series of documents assigned a letter/number combination and filed in a subject category. The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

- *Email - Other* contains 50 assets, of which 25 are released in full, 15 are withheld in part, and 10 are withheld in full.
- *Email - Presidential* contains 217 assets, of which 124 are released in full, 35 are withheld in part, and 58 are withheld in full.
- *Shared Drive - CEA* contains 1 asset, of which 1 is released in full.
- *Shared Drive - OA* contains 5 assets, of which 1 are released in full and 4 are withheld in full.
- *Shared Drive - WHO* contains 92 assets, of which 11 are released in full, 2 are withheld in part, and 79 are withheld in full.
