The materials in FOIA 22-16548-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-16548-F requested materials related to the Pharmaceutical Researchers and Manufacturers Association (PhRMA) from 1/20/2009 to 3/23/2010 to or from David Axelrod, Rahm Emanuel, and Steve Ricchetti.

This FOIA primarily contains correspondence, event and media planning, meeting logs, visitor records, press releases, calendars, schedules, news clippings, and memoranda.

System of Arrangement

The materials in FOIA 22-16548-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files, White House Counsel's Office (WHCO) Staff Member Office

Files, and Obama Presidential Electronic Records.

WHORM Subject and WHORM Alpha Files are processed at the document level.

The WHORM Alpha File was compiled by the White House Office of Records Management and is a series of documents arranged by name of persons, organizations, or events.

The WHORM Subject File was compiled by the White House Office of Records Management and consists of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories, including a detailed description of each category, is available [on the National Archives Catalog](#).

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity. Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

Email – Other Axelrod Rahm Ricchetti contains 102 assets, of which 11 are released in full, 2 are withheld in part, and 89 are withheld in full.

Email – Other FROM Axelrod Rahm Ricchetti contains 51 assets, of which 17 are released in full, 2 are withheld in part, and 32 are withheld in full.

Email – Presidential Axelrod Rahm Ricchetti contains 436 assets, of which 7 are released in full, 3 are withheld in part, and 426 are withheld in full.

Email – Presidential FROM Axelrod Rahm Ricchetti contains 113 assets, of which 5 are released in full, and 108 are withheld in full.

Shared Drives CEA contains 3 assets, of which all 3 are released in full.

Shared Drives OA contains 8 assets, of which all 8 are withheld in full.

Shared Drives WHO contains 25 assets, of which 3 are released in full, 4 are withheld in part, and 18 are withheld in full.
