FOIA 22-17714-F requested materials related to Hurricane Electric.

This FOIA primarily contains email, correspondence, spreadsheets, manuals, pamphlets, presentations, and lists. Among these are conference invitations and planning materials, communications about internet connectivity and website administration, newsletters, news digests, and advertisements.

System of Arrangement

The materials in FOIA 22-17714-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of documents, folders, and electronic search results lists (SRLs) that were processed in response to FOIA 22-17714-F:

Electronic Records

- *Exchange - Other - Hurricane Electric* contains 99 assets, of which 58 are released in full and 41 are withheld in full.
- *Exchange - Presidential - Hurricane Electric* contains 271 assets, of which 122 are released in full, 6 are withheld in part, and 143 are withheld in full.
- *CEA - Hurricane Electric* contains 4 assets, of which 2 are released in full and 2 are withheld in full.
- *NSC - Hurricane Electric* contains 23 assets, of which 3 are released in full and 20 are withheld in full.
- *OA - Hurricane Electric* contains 28 assets, of which 6 are released in full and 22 are withheld in full.
- *PIAB - Hurricane Electric* contains 1 asset, of which 1 is released in full.
- *WHO - Hurricane Electric* contains 10 assets, of which 1 is released in full, 6 are withheld in part, and 3 are withheld in full.
