### **Scope and Content Note**

The materials in FOIA 23-00267-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 23-00267-F requested materials related to a May 2012 meeting in Hong Kong between the U.S House of Representatives Permanent Select Committee on Intelligence (HPSCI) and Wuawei's founder Ren Zhengfei.

This FOIA primarily contains news digests and reports. The digests contain snippets of news stories relevant to various agencies and departments. In addition to annual reports to congress, there are also investigative reports on Huawei.

### **System of Arrangement**

The materials in FOIA 23-00267-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the

White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

### **Electronic Records**

Email - Presidential contains 19 assets, of which 1 are released in full and 18 are withheld in full.
