FOIA 22-16621-F requested materials related to any records mentioning Melissa Hathaway, cybersecurity advisor.

This FOIA primarily contains news articles and briefings, press releases, publicly released statements, correspondence, email correspondence, memorandums, policy reports and statements, public remarks, congressional testimonies and transcripts.

System of Arrangement

The materials in FOIA 22-16621-F (segment 1) are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

Electronic Records

Email - Other contains 3201 assets, of which 2831 are released in full, 34 are withheld in part, and 336 are withheld in full.

Email - Presidential contains 2860 assets, of which 975 are released in full, 58 are withheld in part, and 1827 are withheld in full.

Shared Drive OA contains 900 assets, of which 56 are released in full, 0 are withheld in part, and 844 are withheld in full.

Shared Drive PIAB contains 122 assets, of which 48 are released in full, 2 are withheld in part, and 72 are withheld in full.

Shared Drives NSC contains 716 assets, of which 258 are released in full, 2 are withheld in part, and 456 are withheld in full.

Shared Drive WHO contains 2154 assets, of which 1037 are released in full, 23 are withheld in part, and 1094 are withheld in full.
