Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records

The Executive Office of the President (EOP) instance of the Electronic Records

Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

- *File Share (Communications Folder)* contains 15 assets, of which 5 are released in full, 4 are withheld in part, and 6 are withheld in full.
- *File Share (Press Folder)* contains 7 assets, of which 1 is released in full and 6 are withheld in full.
- *Email_Presidential* contains 6227 assets, of which 3403 are released in full, 420 are withheld in part, and 2404 are withheld in full.
