FOIA 24-23698-F requested all videos and photographs containing the actor, Jerry Seinfeld.

This FOIA primarily contains photographs from the Gershwin Prize concert honoring Paul McCartney in the East Room on June 2, 2010, and President Barack Obama and Jerry Seinfeld recording segments for the web series "Comedians in Cars Getting Coffee" around the White House on December 7, 2015.

Audiovisual records proposed for opening in this segment includes video footage of President Obama and Jerry Seinfeld recording segments for the web series "Comedians in Cars Getting Coffee" around the White House on December 7, 2015.

System of Arrangement

The materials in 24-23698-F (segment 1) are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas Obama Presidential Electronic Records and White House Communications Agency.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
