FOIA 22-16572-F.7 requested all photos and videos from White House and Camp David movie screenings. All photos for this FOIA were previously released in segment 1 of this FOIA.

This FOIA primarily contains video clips shot at the screenings of the Vice documentary *Fixing the System* on September 18, 2015, and videos clips from the *Star Wars: The Force Awakens* screening for military families on December 18, 2015.

System of Arrangement

The materials in FOIA 22-16572-F.7 are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - White House Communications Agency.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
