FOIA 25-11184-F requested all photos of Ronnie Cho, Associate Director of the Office of Public Engagement, from January 20, 2009, to January 20, 2017.

This FOIA primarily contains photographs of President Obama taking departure photos in the Oval Office with Ronnie Cho on April 29, 2010, and November 15, 2013. There are also photos of President Obama participating in a Campus Champions of Change in the Eisenhower Executive Office Building on March 15, 2012, and talking with Ronnie Cho in the Outer oval Office on March 14, 2013.

## **System of Arrangement**

The materials in FOIA 25-11184-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
