Scope and Content Note

The materials in FOIA 25-12322-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 25-12322-F requested photos and videos from inside the White House on January 20, 2017.

This FOIA primarily contains photographs of President Obama visiting the Oval Office for the last time. There are photos of President Obama and First Lady Michelle Obama greeting President-elect Donald Trump and Melanie Trump upon their arrival and hosting an inaugural tea. There are also photos of the Obamas bidding farewell to the Ushers Office and Residence staff.

There is footage of President Obama and Vice President Biden separately walking along the Colonnade. There is also footage of The Obamas greeting the Trumps and the Bidens greeting the Pences upon arrival.

System of Arrangement

The materials in FOIA 25-12322-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records and White House Communications Agency.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
