FOIA 25-21833-F requested photos of Emmett, Catherine, Maeve, and/or Agnes Beliveau from 2009 - 2015.

This FOIA primarily contains photographs from meetings in the Oval Office, the Situation Room, and elsewhere throughout the White House; on travel aboard Air Force One, Marine One, and Bright Star; from departure and award ceremonies; and of the Beliveau family visiting the White House.

System of Arrangement

The materials in FOIA 25-21833-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that

represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
