FOIA 22-33161-F requested materials related emails, communications, or correspondence in the email account of John Podesta sent or received from the domains "americanprogress.org," "americanprogressaction.org," "wyssfoundation.org," "wysfactionfund.org," or "loreda.org" from December 1, 2013 to March 1, 2015.

This FOIA primarily contains emails between John Podesta and individuals at the Center for American Progress (CAP).

System of Arrangement

The materials in FOIA 22-33161-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama

administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

Electronic Records

Email contains 677 assets, of which 249 are released in full, 74 are withheld in part, and 354 are withheld in full.
