Official records of Barack Obama's presidency are housed at the Barack Obama Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

### **Scope and Content Note**

The materials in FOIA 22-41795-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-41795-F requested materials related to President Obama's personal expense reports from January 20, 2009 to January 20, 2017. This being the \$50,000 per year allotted to presidential spending.

This FOIA primarily contains email correspondence and files related to the President's yearly allowance of \$50,000 to assist in defraying expenses relating to or resulting from the discharge of his official duties (3 USC § 102). The bulk of the records are the Executive Office of the President Overview Fiscal Year Budget reports.

### **System of Arrangement**

The materials in FOIA 22-41795-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

Email\_Presidential 2 contains 58 assets, of which 1 is released in full and 57 are withheld in full.
