The materials in FOIA 22-27339-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-27339-F requested materials related to any email correspondence sent from the account of then-White House Chief of Staff Rahm Emanuel between the dates of January 20, 2009 to October 1, 2010 that includes any of the following search terms: "climate bill," "climate legislation," "climate change legislation," "climate," "endangerment finding," "Lisa Jackson," or "Waxman-Markey."

This FOIA primarily contains email correspondence from Rahm Emanuel about climate change policy and the Deepwater Horizon oil spill.

### **System of Arrangement**

The materials in FOIA 22-27339-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

### **Electronic Records**

Email-Presidential contains 307 assets, of which 10 are released in full, 2 are withheld in part, and 295 are withheld in full.

Email-Other contains 134 assets, of which 4 are released in full, 1 is withheld in part, and 129 are withheld in full.

Email-SIP44 contains 1 asset, of which 1 is withheld in full.
